LEGAL COSTS

We offer a variety of services that have different costs.

Where possible we provide a fixed fee such as for estate planning and conveyancing.

We do not offer free interviews but rather have carefully designed a range of instruction booklets which save time and effectively 'skip' the questions asked at free interviews with other providers. In this way you receive the same benefit but also get better and more informed advice from the outset.

Where there is no fixed fee our solicitors charge in accordance with the industry standard which is known as the Supreme Court Scale. This scale is in our Boylan Lawyers Scale of Costs follows this page. Our partners' fees are charged at a higher rate as described on the following page.

Our Terms of Trade are that all Invoices are payable within 7 days. Boylan Lawyers can stop acting for a client if an account is not paid. Account rendered notices attract a \$5.50 fee. Interest of 10% per annum is charged on unpaid accounts.

For matters where legal fees will exceed \$1,500 we will provide you with a detailed terms of engagement. Please raise any questions you have about fees with us.

NO WIN NO FEE AND DEFERRED ACCOUNTS

In some personal injury cases we act on a no win no fee basis where we do not get paid unless we are successful. In others we act on a deferred fee basis where we are prepared to wait for payment of most of our fees until the settlement amount is received. Partners determine whether we are engaged in this way on a case by case basis.

There is a client assessment process to complete in order to be accepted on a deferred fee basis. During this assessment, we will charge in accordance with the Boylan Lawyers Scale of Costs. If you do not qualify for a deferred basis, then you will be liable to pay our fees in accordance with our usual terms.

TRUST ACCOUNT

At the beginning of your matter we may request that you pay a retainer for our fees into our trust account to be held in our trust account until the conclusion of your matter or in the event you stop instructing us. That amount remains in trust and is used to pay future disbursements or an outstanding monthly bill. If the trust amount goes below our retainer amount, for disbursements or payment of overdue accounts, then we will ask you to 'top up' the trust account so that it remains at the retainer amount. For most clients the retainer amount sits in trust until the finalisation of their matter and they simply pay each month as their matter progresses.
